#### **Draft National ECD Policy of the Republic of South Africa**

The Southern African Catholic Bishops' Conference Parliamentary Liaison Office (CPLO) welcomes this opportunity to comment on the Draft National Early Childhood Development Strategy. ECD is fundamental to the successful implementation of the Children's Act. We note that many of the concerns that we raised in an earlier Submission have been addressed in this document.

We welcome the fact that the draft policy addresses a number of crosscutting service domains, i.e. health, nutrition, social protection, parental support and opportunities for learning. Also, much attention has been given to the costing of the different aspects of ECD services.
