## Migrants, Refugees and Displaced Persons

Of great significance, the Minister of Home Affairs, Dr Aaron Motsoaledi, has announced that at the end of 2023 the Lesotho Special Permits will not be renewed. This follows a similar decision regarding the Zimbabwean Exemption Permits. The Minister has indicated that this is part of an overall redesign of migration policy. The Lesotho permits affect about 90 000 people.

The vexed issue of the ZEPs continues to dominate the policy landscape. The DHA recently announced that only about 4% of those holding the ZEP have applied for alternative visas. This amounts to about 6 000 persons. This would seem to indicate that many are either planning to return to Zimbabwe or envisage a future 'under the radar'.

As Zimbabweans in SA face uncertainty, many of them have begun tackling the ruptures in relationships with banks, financial institutions and big corporations. At stake is the fear that banks will close ZEP holders' accounts when the deadline is reached, thereby throttling any attempt for the holders to continue living and working in SA, even if without documents.

In early August, the Constitutional Court handed down a judgement in which it held that foreign nationals, even if they had studied and done articles in South Africa, were still not eligible in terms of the Legal Practices Act to practise law in South Africa.

One of the most disturbing events over the past weeks was the upbraiding of a Zimbabwean patient in the Bela-Bela hospital by the MEC for Health in Limpopo, Dr Phophi Ramathuba. On a visit to the hospital she discovered that the patient she was speaking to spoke Shona, and she then launched into an

attack on how foreigners were using SA health facilities and depriving locals of treatment. She said that the Zimbabwean government does not contribute to the health costs of their nationals in SA, and gave vent to much more of the usual anti-foreigner rhetoric to which we have become accustomed. Her comments have resulted in considerable controversy, although in the party political realm they were supported by the Patriotic Alliance. Another worrying aspect is the way in which blame for an increasingly dysfunctional health system is now laid at the door of migrants, and not at the door of corruption, mismanagement, etc. It is also concerning that politicians in senior leadership, who are charged with building the social cohesion of the country, in fact are guilty of lending credibility to xenophobic narratives.
